General Information

All Events are at the – Eastern Missouri Beagle Club, 257 Tagg Road, Troy, MO

(Use Silex, MO for Mapquest) GPS Coordinates: N39.05453xW 91.06575

DIRECTIONS FROM INTERSTATE 70: Take Route 61 North. Go North for about 15 miles. Exit at Route 47 West. Go about 2.3 miles and turn right onto Highway H. Go about 7 miles on Highway H. Turn left onto Tagg Road (gravel road) just before the sign advertising the Kinion Cemetery. Take the gravel road about a mile to the stone house with silver silos and follow the road to the right for about another half mile. This road ends at the gate to the Eastern Missouri Beagle Club.

Come join us at the Eastern Missouri Beagle Club north of St. Louis and watch your PBGVs search for rabbits on EMBC's two hunt fields with dog-proofed fencing. Enjoy practice time and mentoring in the fields on Sunday followed by two days of hunt tests with your PBGVs. All AKC registered PBGVs are welcome, including those with ILP/PAL listings.

A complete copy of the PBGVCA Rules and Regulations with desirable qualities and faulty actions in hunting PBGVs can be viewed at www.pbgv.org.

Dogs entered individually will be placed in packs by the Hunt Secretary.

READ THE FOLLOWING INFORMATION CAREFULLY.

Entries for this hunt are limited and will open on Wednesday, March 16, 2022, at 8:00 am and will close at 5:00 pm, Wednesday, April 6, 2022. Entries postmarked before Wednesday, March 16, 2022, or postmarked after Wednesday, April 6, 2022, shall be considered invalid entries and shall be returned as soon as possible. There are ten hours of run time available. Stakes offered each day will be as follows: 12 pack stakes, 3 brace stake, 3 solo stake, and 4 HIT pack. Entries will be awarded first come, first served based on postal cancellation date. If 1 or more stakes are not completely filled, the Event Committee reserves the right to increase the entry limits on 1 or more of the other stakes based on entries submitted. The Event Committee reserves the right to increase the number of stakes offered, or adjust the schedule, to accommodate additional entries. Entries over the limit are not guaranteed runs. Entries are further limited to 1 run per dog per day. If more entries are received (based on postmark date) than can be accommodated, entries will be determined as follows: First, by postmark date; Second, one or more draws may take place by postmark date to eliminate runs, in the following order: solo runs; then brace runs, then pack runs; starting with handler/households with the highest number of runs, then the handler/households with the next highest number of runs, etc. If one of your runs is eliminated, you will be given the option of adjusting your other entries so the affected dog(s) can still run. Packs and braces made up of dogs from more than one handler will be categorized based on the handler(s) with the fewest runs. Handler/households with multiple entries may attach a letter to the Secretaries indicating preferred priority for runs in the event that an elimination draw is required. handler/household is defined as an individual owner of a dog or members of a household with shared ownership of dogs. A wait list will be created based on postmark date and the run elimination scheme. If not moved off the wait list, a full refund will be made.

Weather in May in Missouri is unpredictable. The event will be held in heat, rain, snow, and cold, so long as it is not deemed unsafe or unjudgable by the event committee. Individual runs may be postponed in the event of unsafe conditions or conditions that make judging impossible. If the entire event is postponed, entrants will be given refunds of entry fees.

Walking sticks and canes will be allowed on the field (using discretion around any hounds that are sensitive to them).

- Refunds for entry fees and prepaid meals will be allowed prior to closing date with written or email notification to the Hunt Secretary.
- No refunds after closing date, except Bitch-In-Season with a veterinarian statement unless the entry can be replaced by a wait-listed entry.
- A refund of entry fees and prepaid meals will be allowed for BIS (not for other PBGVs entered by the entrant, or for pack or brace mates) after closing date with a veterinarian statement.

- Entries that can't be accommodated due to stakes being full will be returned as soon as possible after closing date.
- Grounds will open at 10 am for practice on Sunday and close at sunset.
- The field will be open after tests are completed on Monday and Tuesday depending on available time.

Accommodations:

AREA MOTELS:

The beagle club is 59 miles, or 1 hours and 8 minutes, from the National Specialty hotel, according to Google Maps. The hotel has a block of rooms for those who are going to the National Hunt. The rate is \$124 per night. There is a one time \$25 pet fee (which might be waived – that is not certain). Make reservations by calling the hotel at (314) 821-6600 and ask for a room in the PBGVCA Club of America block.

Unfortunately, Troy Missouri is not a very pet friendly hotel area. There are hotels in Troy but, in the past, they have NOT accepted dogs staying in the rooms except one:

The Troy Inn & Suites (formally Motel 6), 14 Frenchman's Bluff Road, Troy, MO Phone: 636-528-5125, 20 minutes from the hunt field, **accepts dogs** with a daily deposit. Other dog clubs have not had any acceptable reviews for this hotel while it was owned by Motel 6. It is under new management at the present time. A room was viewed, and it was very spartan but clean.

Super 8 Motel 28 Turnbull Trail, US Hwy 61, Exit 47, Troy, MO Phone: 636-385-5331 but, unfortunately, they do **NOT** accept dogs in their rooms. They have a sister Super 8 in Bowling Green, MO (38 minutes north on US Hwy 61) 573-324-6000 that does accept dogs.

Super 8 in Warrenton, MO, accepts dogs. They have at least 8 pet-friendly rooms. \$65 per night plus tax. \$40 refundable pet deposit. The Manager (Jay) indicated they charge \$20 per dog per night. Jay has agreed to accept up to 5 of our dogs per room (2 is the normal policy). 1429 North Service Road East, Warrenton, MO, 63383 (36 minutes southwest). 636-456-5157.

Wentzville and O'Fallon, MO are much larger towns with more motels to offer. They are about 20 miles (40 minutes) south of the field trial grounds off Interstate 70:

Holiday Inn Express & Suites, 1100 Lodora Dr, Wentzville, MO 63385 (36 minutes south of hunt field), 636-887-2700. Very nice hotel, more expensive, accepts dogs. There is a block of 10 rooms under the

event name Petit Basset Griffon Vendéen (PBGV). Rate of \$149 per night plus tax. There is a \$20 dog fee per dog per night. They will accept at least 2 dogs per room – contact the hotel to confirm more than 2 dogs per room will be allowed. The block will be released April 1. Please email btoenjes@gmail.com for the link to reserve rooms in this block (the link was not available at the time of publication of the premium).

Super 8, 987 West Terra Lane, O'Fallon, MO (40 minutes) 636-272-7272. Call the hotel directly – they have a block of 10 rooms under the name "PBGV Club." \$15 fee per dog per night, limit of 2 dogs per room.

There are other hotels in the Wentzville and O'Fallon area: too many to list but here are a few that have accepted dogs in the past. Please check with them regarding their current dog policies.

RV PARKING AND CAMPING:

RV parking and trailer and tent camping is available at EMBC grounds Sunday morning through Wednesday morning. **NO ENTRANCE TO GROUNDS BEFORE 9:00 am on Sunday, May 1.** The clubhouse is air-conditioned and has a shower and two restrooms. Water is available to fill tanks but water hookups are not available at individual sites. There is no RV dump site on the grounds.

Tent camping charge is \$12/night. RV or trailer camping is \$35/night with electrical hookup as available. There are 6 poles with 30 amp service. There are 16 outlets with 20 amp service. Bring extension cords. Inside shower and toilets available. **Judges and working club members will have first rights to electrical hookups.**

RV RENTALS:

M.B. Thomas RV Sales in St Louis does RV rental, including trailers, Class C, and Class A RVs. They are on the south side of St. Louis so delivery of a trailer is probably not an option. See their web site: https://mbthomasrvsales.com/rent-a-rv 800-392-5655

There are several individuals or small companies in the St. Louis area that rent one or two RVs that can be found with a Google search of "RV rental St. Louis", and there are a number of RVs for rent on www.outdoorsy.com or rvshare.com from individuals. You will need to negotiate whether they will deliver and set up, or allow dogs.

NOTICE

- Alcoholic beverages are permitted in the RV and parking area and in the Eastern Missouri Beagle Club but not the hunt fields. Discretion in consumption is required. No smoking in the clubhouse.
- Safety of the dogs is our primary concern. Areas used for the Hunt Tests will be totally fenced.
- In consideration of others, you will be expected to clean up after your dog outside of the fenced hunt fields.
- Handlers must be present at the time of each draw. Hounds will be checked in but need not be present. Hounds not checked in will be marked absent.
- HIT packs will be made up by the Hunt Secretary and may include an experienced dog running "for exhibition only" if possible.
- Individual pack stake entries will be placed in packs by the Secretary prior to the draw.
- You MUST indicate any issues for individual pack entries (i.e., can't run with other males, can't run with intact females) on your entry form. You are responsible for your failure to do so. Reasonable efforts will be made to accommodate such issues, but accommodations are not guaranteed. If an accommodation is not possible, you are responsible for determining whether your dog should run.
- Handlers are requested to be responsible for bitches in season, including segregation from entered dogs and common areas. You are requested to not bring bitches known to be in season if possible.
- Individually entered dogs may be added to pre-arranged packs with the agreement of all affected handlers.
- All handlers will be expected to marshal runs during the weekend. Marshals will be assigned immediately following the draw.

No dogs, other than PBGVs, in the fenced hunt fields at any time.

ENTRIES OPEN ON MARCH 16, 2022, and CLOSE ON APRIL 6, 2022.

THERE WILL BE NO SAME DAY ENTRY.

COVID PROTOCOLS:

The event will require compliance with all protocols required by the AKC, and federal, state or local governments. This may include requiring face masks. The Event Committee reserves the right to impose more stringent protocols for the event such as masking and distancing. Bring enough masks for the entire event. Requirements will be provided to all participants prior to and at the event.

PLEASE NOTE:

- 1. No move-ups from the Hunting Instinct Test to the Hunt Test will be accepted for the day on which the PBGV has been marked as passing the HIT. Move-ups the next day will be subject to space availability. Owners may enter their hounds in the HIT on both test days: a hound that passes the HIT on the first day may move up to the PCJH test on the second day, space permitting (a \$5.00 move-up fee will be assessed).
- 2. The Hunt Test is an off-lead test. No long lines (except as stipulated in the PBGVCA Hunting Rules) or leashes may be used once a PBGV is released until the Judges request the dog(s) be picked up (leashed) to remove them from the field. No food or treats allowed on the fields on Test days.
- 3. If due to darkness the Monday Tests cannot be completed, they will resume first thing on Tuesday morning followed immediately by the draw for the Tuesday tests
- 4. The event committee may delay runs due to weather conditions.

How to complete the entry form

- Call Name: Fill in the familiar name by which you call your dog
- **Collar Color:** Fill this in only if 1) you are providing your own collar(s), 2) you are entering the hound in a predetermined brace or pack and 3) you have determined that no other dog in the pack will be wearing this color.
 - An assortment of collars will be available for anyone needing to borrow a collar for the test
- Male/Female: Check the appropriate box. Females in season may not be on the test field. Fees will be refunded for bitches that come in season after the closing date or a substitution may be made
- AKC Registered Name: Fill in the Dogs full AKC registered name including any AKC and/or PBGVCA titles. This name will be used if a Hunting Certificate/Title is issued
- Individual Entry, Pack Entry: If you are entering a single hound and have not made previous arrangements to run your hound in a pack with others, check the box for Individual Entry. This hound will be packed with others at the draw. If you are entering this hound as part of a prearranged pack, check the appropriate box. Hounds within a pack do not need to have the same owner(s)
- HIT, HT, NLE, and PLE: These abbreviations stand for Hunting Instinct Test, Hunt Test, Novice
 Learning Experience, and Puppy Learning Experience. Check the appropriate box for the events you
 want to enter this hound.

- AKC Reg. No., AKC Litter No., PAL No.: Check the appropriate box and fill in the number
- Date of Birth: Fill in the birth date of this hound
- Place of Birth USA or Other: check the appropriate box, if other, please note the country
- **Handler:** This is the person responsible for the hound on the test grounds
- How to determine the entry fees:
 - Normal fees are as stated on the entry form.
 - For the Hunt Test, the fee for a pre-arranged pack will be based on the number of dogs in the pack. Please fill out a separate entry form for each dog, check the "Pack Entry" box, and fill out the Pack Entry form. All individual entry forms, supplemental entry forms, fees, and the entry summary sheet must be included in the same envelope.
- **Telephone Number and E-mail address:** Please include this information so we may call or email you if we have any questions about the entry. Receipt of your entry will be confirmed by e-mail.

SUMMARY OF RULES AND REGULATIONS for PBGVCA Hunting Tests

Hunting Tests shall be open to all AKC registered or ILP/PAL registered Petit Basset Griffon Vendéens of six months of age or over on the first day of the event. Spayed or neutered hounds are eligible for entry.

No person acting in the capacity of Hunting Tests Secretary may judge at the event for which that person is acting as Hunting Tests Secretary.

Any dog may be entered in a hunt test stake for which it is eligible, however, it must be noted on the supplementary entry form, if an advertised judge, alternate judge or any member of their family has owned, sold, held under license, boarded, trained or handled the dog within one year of the starting date of the Hunt Test, as this person may not judge the hound.

For purposes of this Section, the words "any member of his family" shall include a spouse, a sibling, a parent or a child, whether natural or adopted, of the Judge in question, but shall not extend to other blood or legal relationships.

At the conclusion of the judging for each test, the club shall provide, for the Judges' signatures, the Hunting Test Score Sheets for each pack judged, showing full particulars of all dogs judged.

Titles are awarded based on application to PBGVCA as defined in the Petit Basset Griffon Vendéen Hunt Tests Rules and Standard Procedures.

Purpose: The purpose of Hunting Tests for Petit Basset Griffon Vendéen is to afford an opportunity to demonstrate an individual hound's ability to perform in a manner consistent with the demands of actual hunting conditions. Testing in this manner is to gauge the hound's hunting ability, desirable qualities that indicate ability to be effective and efficient in the pursuit of quarry.

Time and Running Order: Running order will be assigned by public "Draw" before the beginning of each test day.

Packs may be mixed sexes. Bitches-in-season may not be on the test field. Fees will be refunded for bitches that come in season after the closing date or a substitution may be made.

No hounds shall be put down after 30 minutes following official sunset. The Hunting Test Committee and the Judges shall be responsible for enforcement of this Procedure.

Marshals: It shall be the duty of one Marshal to assist the Judges and to carry out their instructions, including regulating and controlling the gallery & seeing to it that the gallery is kept separate from and behind the Judges, and that no one in the gallery talks to the Judges while the dogs are down. Marshals shall assist the Judges in all other matters necessary for the smooth and expeditious running of each Test.

Gallery: No person shall make any remarks nor give any information which might affect the actions of the persons handling the hounds or the running of the hounds unless information is specifically requested by the Judges. Any person so offending may be expelled from the running grounds on orders from the Judges, and points of merit shall not be allowed any hound whose handler acts upon such information. The Judges must be informed of any such misconduct before the close of the running of the hound(s) in which it occurs, and their decision shall be final.

Handlers: When hounds are cast, a handler may speak, whistle, sound a horn to his hound or work in any way he may deem proper, if not contrary to these Procedures, unless otherwise instructed by the Judges. Hounds must show reasonable obedience to their handler's commands.

Each hound under judgment must wear a different colored hunt collar or stretch band for easy identification by the Judges. The Judges' evaluation forms will have this collar color and the handler's last name. (Personal collars worn in addition to the colored hunt collar or stretch band must have a fixed circumference with no hanging tags.)

No owner or handler shall have any right to question or refuse to follow the Judges' orders.

Owners and handlers must keep themselves informed as to the running order and progress of the judging and must be ready within hailing distance when their hounds are called by the Marshal on instruction from the Judges.

Severe Training or Correction: The Hunting Test Committee and the Judges shall not permit severe disciplining of hounds on any part of the grounds. The Committee shall investigate any reports of such conduct or of any other conduct prejudicial to the best interests of purebred dogs, PBGVCA Hunt Tests, or the American Kennel Club, according to Chapter 6, Section 5 of the Petit Basset Griffon Vendéen Hunt Tests Rules and Standard Procedures.

The title of Hunting Instinct Certified will be granted by the PBGVCA to any Petit Basset Griffon Vendéen passing the Hunting Instinct Test. If requested by the owner, this title will be designated by the suffix title HC in all PBGVCA records.

Hunt Test

Open to any PBGV who has passed a PBGVCA Hunting Instinct Test, or received an equivalent qualification by an established hound association. All qualifying scores must be applied towards an appropriate hunt title for which a prerequisite has been earned. High qualifying scores may not be saved for advanced titles.

Titles:

- The title of Parent Club Junior Hunter shall be granted to any PBGV receiving three qualifying scores of 100 or better: 1) all from pack stake 2) with a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCJH in all PBGVCA records.
- The title of Parent Club Junior Hunter Excellent shall be granted to any PBGV receiving three qualifying scores of 100 or better with: 1) two from pack stake, one from brace stake 2) a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCJHX in all PBGVCA records.
- The title of Parent Club Senior Hunter shall be granted to any PCJH or PCJHX titled PBGV receiving three qualifying scores of 100 or better from pack and brace stakes, any combination, with: 1) a minimum of two qualifying scores of 125 or better, 2) a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCSH in all PBGVCA records.
- The title of Parent Club Senior Hunter Excellent shall be granted to any PCJHX titled PBGV receiving three qualifying scores of 100 or better from any stake, minimum of two different stakes, with: 1) a minimum of two qualifying scores of 140 or better, 2) a minimum of two different hunt sites, 3) a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCSHX in all PBGVCA records.
- The title of Parent Club Master Hunter shall be granted to any PCSH or PCSHX titled PBGV receiving one qualifying score of 100 or better in each of three stakes with: 1) a minimum of two scores of 150 or better, 2) a minimum of two different hunt sites, 3) a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCMH in all PBGVCA records.
- The title of Parent Club Master Hunter Excellent shall be granted to any PCSHX titled PBGV receiving one qualifying score of 100 or better in each of three stakes with: 1) a minimum of two scores of 160 or better, 2) a minimum of two different hunt sites, 3) a minimum of three different Judges. If requested by owner (see Section 8) this title will be designated by the suffix title PCMHX in all PBGVCA records.
- The title of Rabbit Hunter Excellent shall be granted to any PBGV receiving 10 qualifying scores of 100 or better in any stake after completing the prerequisite titles of Parent Club Master Hunter and Parent Club Master Hunter Excellent. If requested by owner (see Section 8) this title will be designated by the suffix title RHX in all PBGVCA records. A numerical suffix may be added to the title with each additional 10 qualifying scores, RHX2, RHX3, etc.
- The title of Elite after any Parent Club Hunter title shall be granted to any PBGV that has
 earned a PCJH title or higher and produced a minimum of three Get with: 1) PCSH titles, 2)
 from two or more different Sires/Dams. Elite Titles may be awarded posthumously. If
 requested by owner (see Section 8) this title will be designated by the second suffix ELITE
 after the Parent Club Hunt Title (i.e. PCSH, ELITE) in all PBGVCA records.
