I _____ agree to foster this Petite Basset Griffon Vendéen dog for the PBGV Rescue Committee, and release PBGV Rescue, PBGVCA, and their individual members from all claims for personal injury and/or property damage to myself or others associated with this foster care. I acknowledge receipt of the PBGVCA Foster Dog Manual and agree to take care of this dog in accordance with that document. This dog will not be used for breeding, medical, or experimental purposes. I understand that if I give false information or do not follow the terms of this contract, PBGVCA Rescue may reclaim this dog and start legal proceedings against me at my expense, and may assess damages in the amount of \$500 against me. I agree to the following terms:

1. I will not receive any monetary compensation for the services I will provide to this dog.
2. I have the right to return this dog to PBGV Rescue for any reason.
3. Veterinary care: this dog's health is my responsibility, in cooperation and consultation with the PBGV Rescue Committee. The PBGV Rescue Committee will pay for veterinary expenses as detailed in the Foster Dog Manual. After receiving the dog, I will take it to a veterinarian within seven days (by / /) for a thorough examination and any necessary inoculations. First examination will include stool check and heartworm test, if appropriate.
4. The dog will reside at my home address as listed above. I will timely notify PBGV Rescue of any changes in my address or contact information.
5. I will telephone my PBGVCA Rescue Agent immediately if this dog becomes lost or injured.
6. I will keep this dog as a house pet. The dog will sleep indoors. I will keep ID on this dog at all times.
7. I will provide the dog with loving and humane care and maintain the dog in accordance with all applicable state, county and municipal laws and ordinances while the dog resides with me.
8. I will provide a crate, leash, adequate food and fresh water, and toys.
9. My personal pets, if any, are current on their vaccinations, including Bordatella (for dogs), which is not a routine vaccination.
10. This dog will be provided with humane means of exercise, such as regular walks and a fenced yard. The dog will not be kept constantly tethered indoors or outdoors. The dog will be leashed at all times when outside in an unfenced area and shall not be taken to an off-leash dog park.

11. The dog will be given normal grooming, including trimming of toenails. Other than normal grooming, the dog's appearance will not be altered, including removal of dewclaws or cropping of ears or tail.

12. If I can no longer keep this dog, I will notify PBGVCA Rescue to arrange for its rehoming. I will not transfer this dog to another person or to a shelter, nor will I abandon it.

13. PBGVCA Rescue will contact me for verification of the dog's condition and welfare. I will cooperate by providing whatever information is requested, and I will permit a representative of PBGVCA Rescue to visit my home if so requested.

14. I will not hold PBGVCA Rescue responsible for any errors in information provided to me.
