Directions to the trial site:

Top Dog Training Center - 18612 Bandera Rd, Helotes, TX 78023

FROM THE WEST: Loop 1604 East, exit Bandera Rd., Hwy 16. Turn left onto Bandera Rd. Go 7 miles. Turn right into driveway, and enter into the left gate. Go approximately 1 mile (15 mph) and go through the 2nd gate. Turn left and go over the bridge, follow the road up to Top Dog Training Center.

FROM THE EAST: . Loop 1604 West, exit Bandera Rd., Hwy 16. Turn right onto Bandera Rd. Go 7 miles. Turn right into driveway, and enter into the left gate. Go approximately 1 mile (15 mph) and go through the 2nd gate. Turn left and go over the bridge, follow the road up to Top Dog Training Center.
